

SECTION 1 - MANTUS MARINE LIMITED WARRANTY, PUBLISHED 2024 Q4

MANTUS MARINE LIMITED WARRANTY

Mantus Marine's warranties, both express and implied, are only applicable to the original purchaser and non-transferable. Mantus Marine reserves the right to deny warranty claims where proof of original purchase cannot be provided.

Meaning: This warranty applies only to the original purchaser. The history of the product becomes difficult to determine once it is second or third-hand, and it may have been damaged and repaired at some point, therefore becoming weakened.

COVERAGE

Mantus Marine warrants that the product will be free from material defects and failure of material and workmanship for the time periods outlined, specific to the referenced components below.

ANCHORS - LIFETIME

Mantus Marine Anchors are warranted against bending or deformation under normal use for the *LIFETIME* of the original owner.

Galvanized coatings on anchors and anchor bolts are warranted for a period of 3 years from the date of purchase.

STAINLESS STEEL - 5 YEARS

Stainless steel components are warranted for a period of 5 years from the date of purchase.

Failure to apply seizing wire or a cotter pin as a locking mechanism to applicable products, such as Shackles and Swivels, will void any warranty coverage of those products. Chain is excluded from this warranty; see the manufacturer warranties below.

LINE AND SOFT GOODS - 3 YEARS

Line integrity, including splicing, is warranted for a period of 3 years from the date of purchase.

Product failure due to inappropriate sizing, chafe, or failure of whipping is excluded from this warranty.

LIGHTS AND ELECTRONICS - 3 YEARS

All electronic light products are warranted for a period of 3 years from the date of purchase.

Failure to close charging port covers will result in water intrusion and will be excluded from this warranty.

REPLACEMENT PARTS - 1 YEAR

Springs in products like the Mooring Snap Shackle and M3 Chain Hook are warranted for a period of 1 year from the date of purchase.

Replacement parts like Cotter Pins, Seizing Wire, and M2 Chain Hook Straps, are considered wearable or consumable parts, and therefore are not covered by this warranty. It is the responsibility of the user to check and maintain these parts according to the manufacturer's published guidelines.

4 YEARS

Hull - The hull is defined as the HDPE boat hull plus seats. The hull is warranted for a period of 4 years against defects in material or workmanship such as cracks, deformation, and discoloration. This warranty does not include superficial surface blemishes or abrasions.

Handles and Cleats - Handles and cleats are warranted for a period of 4 years against defects in material and workmanship.

1 YEAR

Wearable Parts and Accessories - Wearable parts and accessories are warranted for a period of 1 year against defects in material and workmanship. This includes Bumpers, Bags, Oars, Rowlocks, Wheels, Pads, Steps, Drain Plugs, Deck Plates, or any other part that can reasonably be considered wearable or consumable.
